Filtering and monitoring: Securly (filter) and Firewall (Palo Alto) in place.

Online safety DSL completes weekly monitoring and records on spreadsheet Acceptable use agreements signed by pupils/parents

Staff report low-level concerns to HT and detailed records kept securely All staff have access to Cpoms to record concerns and raise issues with DSLs – regular training is provided

All new staff provided with training on how to report concerns on CPOMS Operation Encompass uploaded to Cpoms and minutes from any meetings attended

DSLS meet fortnightly: file reviews; update monitoring list; review patterns/learning from incidents; discuss referrals; identify training needs DSLs have password protected spreadsheet to keep logs of: Monitoring list (shared fortnightly with all staff); Securly monitoring and checks; STRAT meetings attended; audits; training; incidents and outcomes; Young Carers; external referrals; escalations

Half-termly Link AQC member visits with relevant staff to focus on key areas – reported back to whole AQC

Prevent Risk Assessment in place

HR and Trust Compliance Team monitor and keep records of all training completed

DSL attends half-termly safeguarding meetings with The Prospect Trust team and consultants from Brightcore Consultancy

Red/green lanyards used to identify compliant/non compliant visitors in school Clear system in place for volunteers to become compliant before helping in school

Regular worship sessions around safeguarding for whole school – led by Pastoral DHT

A DSL or DDSL will always attend every residential

A DSL or DDSL will always be on site or available by phone during school hours

All parents able to access a DSL by using DSL@ email address – this is published on the website

Culture

All DSLs attend updated training, and this is disseminated to staff

Regular safeguarding training for all staff on National College and as part of all INSET days

Excellent communication between staff members

Regular Wellbeing and Online Safety newsletters for staff and parents Safeguarding posters around school, emailed to visitors and shared with supply staff and work experience students

Safeguarding walks – used to check staff understanding of procedures DSLs regularly discuss key pupils and clear lines of communication using Cpoms

Weekly attendance checks in place and shared with staff: "walk towards" families of concern

Monitoring system in place for key children of concern – all staff aware DSL/DDSL attends Surrey Safeguarding network meetings to keep updated on changes.

Safeguarding updates are shared with staff in meetings or via email. Regular whole school Worship sessions around Keeping safe/Mental Health/Anti-bullying

Weekly Tech Thursday Worship sessions — keeping safe on line Themed days and lessons used to deliver key messages ie NSPCC Speak Out, Antibullying week, Breck Foundation, Mental Health Week / Awareness day Safeguarding board for staff (staff room)

Training:

All training courses are logged by the Trust HR team

Staff have full access to training courses on National College

All safeguarding leads/EVCs training up to date

DSL attends Surrey termly safeguarding updates

Staff safeguarding training delivered annually through a whole school INSET day, with additional updates throughout the year (via face-to-face meetings or email correspondence)

Annual bespoke training day with Brightcore for DSL/DDSL

Staff trained for Safer Recruitment: CW, SW, RF, KG

Termly supervision for Family Link Worker and 2 ELSAs

FLW attend Police Intelligence Briefings

2 x sessions for all staff led by MHST

Senior Mental Health leader training

Mental Health First Aiders trained (x4)

Pupil Voice engagement and feedback

Regular pupil voice carried out by school staff regarding a range of safeguarding issues eg Online Safety and Relationship Education Regular pupil, DSL & Safeguarding AQC interviews

Annual pupil voice as part of annual audit from external provider (Brightcore)

What the feedback tells us: children know how to keep themselves safe both on and offline; they know who to share concerns with and feel that adults will listen to them; they feel empowered about making or bringing about change in the school; they enjoy PSHE lessons and talk positively about lesson on mental health, self-esteem, body image and first aid.
